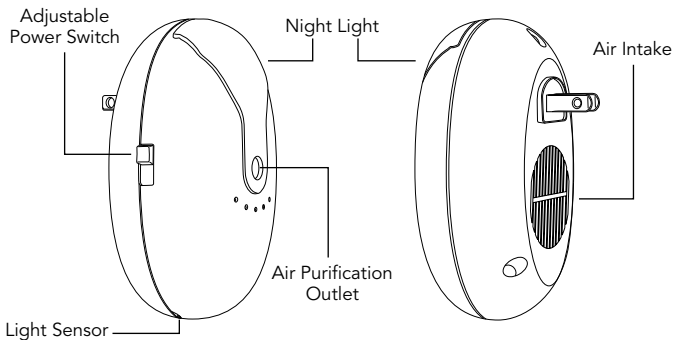

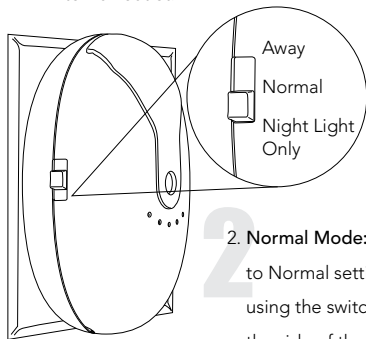

## INSTALLATION

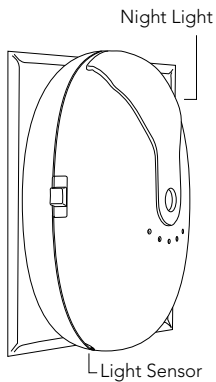
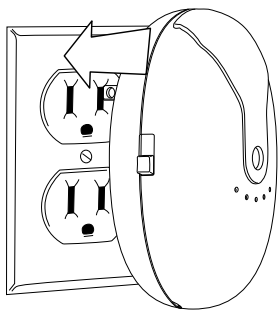
1. With the switch in Night Light Only, plug the Fresh Air Focus into wall outlet.



2. **Normal Mode:** Adjust to Normal setting using the switch on the side of the unit.

**Night Light Only Mode:** If desired, the Focus may be set to Night Light Only (air purification function OFF).

**Away Mode:** The Away Mode setting is for unoccupied spaces that need extra attention.

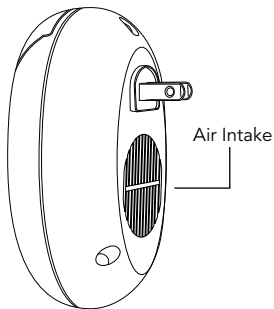
